Fraudsters, who acquire personal information through social media or illicit data purchases, craft deceptive stories to prey on grandparents' concerns. These scammers may impersonate a grandchild or relative in distress, requesting immediate financial assistance,

sometimes even using caller ID manipulation to appear as though the call is from a trusted source. Scammers can now use Artificial Intelligence (AI) to "clone" the voice of a loved one, making the deception more convincing. To protect yourself, never trust the voice alone. Always verify the situation by contacting the supposed caller directly through another communication method.
