Money Matters – Questions from Your Grandchildren (Part 3 of 12):

Should I Leave Money in my will to my grandchild?

There is no single answer. Some grandparents choose to, while others prefer to leave their estate to their adult children. Often, adult children in their 50s or 60s are already financially secure, yet there can still be a sense of tradition in leaving funds to them rather than directly to grandchildren. For those considering leaving something to younger grandchildren, one approach sometimes used is a *Uniform Transfers to Minors Act (UTMA) account*. This allows funds to be managed by a parent, aunt, or uncle until the child reaches adulthood, without the need for guardianship.
